The annual fee for the full time programme, after LTA and Virtus subsidy has been applied, is £9,200. This is split into 12 monthly payments of £766. The first payment is due as a deposit prior to the start of the programme and the following 11 payments are scheduled for the 1st of each month from September to July.

Funding received from the LTA in support of RPDC players is attributed in its entirety to subsidise the cost of the programme. It is split proportionally between the full- and part-time players. An additional subsidy is provided by Virtus at a discretionary amount and applied proportionally across all full- and part-time players.

1. Squad fees are based on a 39-week training year for coaching sessions.
2. A deposit (to the value of 1 month's payment) is taken upon successful application. A further 11 monthly payments are scheduled for the 1st of each month starting September 2025. The final payment will be scheduled for 1st July 2026. **These payments cover services delivered between 1st September 2025 and 31st August 2026.**
3. The Funded Programme is a one year commitment. Players wishing to leave the programme before the end of this agreement must give a minimum of **3 months' notice** in writing. This can be via email to James (james.langford@bromleytenniscentre.co.uk).
4. A player can be removed from their programme with immediate effect at the discretion of management. In this instance, future scheduled payments will be cancelled.
5. Should payment not be made in accordance with the payment plan, the player's programme will be stopped immediately.
6. In the event of a failed scheduled payment we will attempt to re-run the payment the following day at no extra charge. In the event of a 3rd failed payment, a £50 processing fee will be added to the cost of that month's payment.
7. In the event of having to take recovery action for payment, an administration charge of £80 + VAT will be applied plus the costs incurred for the recovery.
8. Any discounts or rebates are entirely at the discretion of Bromley Tennis Centre management and there are no refunds for training absences other than at the Centre's discretion. Prolonged injury or illness are subject to the normal terms and conditions displayed in the reception area and discretion of management.
